Policy Agreement & Permission Waiver

Dear Parent(s)/Guardian(s), & Athlete(s),

The Town of Cramerton strives to bring you and your athlete the best learning environment possible. We would like your experience here to be as safe and enjoyable as possible. We have rules and policies that MUST be followed. All participants are required to carefully read and sign the following policy agreement and permission waiver. We would like to thank you for choosing gymnastics, and we hope that you have a wonderful learning experience.

-**Registration Fees:** Each participant is required to pay a seasonal club membership fee to the Town of Cramerton due at the start of that season. This fee is non-refundable and non-transferable. Children may enroll at any time of the season.

- **Tuition Policies:** Tuition is due the first class of each month. Any payments received after the 10th of the month are late and will be charged a \$15 late fee. WE DO NOT SEND STATEMENTS UNLESS/UNTIL PAYMENT IS LATE. Monthly payments are calculated based on the average of 4 classes per month within the given semester. Each year, three semester sessions are offered as follows: Fall/Winter(Sept-Dec), Spring(Jan-May), Summer (June-Aug). Fees may be paid per individual class, per month, or per semester. Registered students are those who pay per month or per semester, and will be guaranteed a place on roster, all others will only be allowed if space is available at the time of the class.

-I understand that at the time of enrollment, my athlete(s) is/are enrolled in a full semester. If my child must discontinue for any reason before the end of the semester session, a 15 day written notice is required. If this notice is not received, I will be charged for the month(s) tuition.

-**Returned Checks:** There will be a fee of \$25.00 per returned check.

-**Restrictions:** the coaches reserve the right to replace/withdraw any class participant who has become a disruption/behavioral problem, unpaid fees, had 3 consecutive weeks of absence, or any other reason coaches deems reasonable.

- **Release:** we require a known parent/guardian to pick up child at the entrance doors of the gym when class is dismissed. For their safety, no child is allowed to walk outside without a chaperone.

-**Attire:** Females should wear a **gymnastics leotard**, without an attached skirt. Biker shorts and/or tights over the legs only, may be worn. Anti-slip socks or bare feet will be required. Long hair must be up in ponytails, short hair pulled off of face, and please do not use scrunchies or holders with hard pieces. No mid drift shirts, T-shirts, baggy clothes or jewelry of any kind will be permitted.

Males should wear flexible **t-shirt** and **shorts** that will stay tucked in. Clothing must be made without buttons, zippers or snaps. Clothing that is overly loose and baggy can make it difficult for the instructors to spot your child. Anti-slip socks or bare feet will be required. No jewelry of any kind will be permitted.

-**Waiting Area:** Parents are not allowed inside the gym area during classes or events unless otherwise noted. This is for safety purposes. We provide showcases and special times for viewing participants. Please supervise your child(ren) while in the waiting area. No running, jumping, swinging, or horseplay allowed. Violators will be asked to leave.

- **Make Up Classes:** Each student in a class will be allowed make-up classes for missed registered/paid classes. All absences must be made-up within 1 month of the absence. Anything not made up within time frame will be forfeited. All make-up classes must be scheduled and will only be allowed if space is available in that class time.

- **Gym closures:** The gym follows the Gaston County School District schedule for weather related closures and honors the following holidays: New Years Eve, New Years, Easter, Independence Day, Thanksgiving, Christmas Eve and Christmas. Specific additional closures are subject to the coaches and Town of Cramerton scheduling and will be announced in advance.

- **Release & Waiver:** I am fully aware and appreciate the risks, including but not limited to the risk of catastrophic injury, paralysis, or death, as well as other damages, and losses associated with the participation in gymnastics, cheerleading,

tumbling, and other associated classes and events with the coaches and the Town of Cramerton, no matter the location of the event.

- I hereby for myself, my children (adopted or otherwise), my heirs and executors, waive and release any and all rights against the Town of Cramerton, their agents or representatives (contracted, hired, or volunteered) for any injury or damages that may be suffered by me, my children (adopted or otherwise), in connection with my association or entry in classes, practices, exhibitions, competitions, or any other event(s) sponsored by the Town of Cramerton.

- Medical Attention: *I hereby give my consent for the Town of Cramerton representative(s) and/or coach(es) to provide customary medical/athletic attention and /or emergency medical services in the event that neither parent nor guardian may be reached.*
